STANDARD ITEMS: This portion of the meeting, the community speaks to the SRVA to inform us of community information that is relevant to the SRVA purpose and mission.

- 1) Call to Order; Invocation / Pledge of Allegiance The meeting was called to order at 7:00PM by the President of the board Mr. Schwarzkopf
- 2) Roll Call; must have a quorum of at least 5 Directors and at least 2 Officers present.
