- 5) Approval of Minutes:
 - a. Minutes from prior meeting were distributed and reviewed.
 - b. There being no revisions to the meeting minutes, Patrick Graham made a motion to approve the minutes from the January 2020 meeting; Stan Lenox seconded the motion. The Motion passed.
- 6) Consideration of Appointment to fill vacant Board Member position (if needed):
 - a. We wish to show appreciation to Dedra Ecklund. This meeting marks one year since she joined the SRVA BoD. Thank you Dedra for your outstanding work for the SRVA.
- 7) Township/Village Liaison Report: John Osborne delivered the report, which board members read.

The SRVA Fishing Tournament and the BBQ Challenge is included in the events calendar. Information was provide regarding the 6th Annual Community Tree Planning on February 8, 2020 from 8:00 am to noon. The Concerts in the Park and Waterway Nights will begin in the spring. The Emergency Preparedness Event will be held at The Township offices on March 28, 2020. The public safety open houses will be on June 20, 2020; Gosling Road will be 10-noon and Branch Crossing 1-3pm. This is a fun event for children.

Mr. Stan Lennox asked a question about the water line leaks at Ashlane Way and Woodlands Parkway. There is a new traffic pattern on New Trails near The Township offices.

8) President's Report

- a. Joe Havrilla is running for re-election. Jeff Conn expects to be re-nominated.
- b. Service Agreement Discussion. Are there any concerns? Has everyone seen it? Robbye Schwarzkopf has the forms and Tom Schwarzkopf is preparing the information for submittal.
- c. Discuss possible nominations for new officer's positions beginning March 2020.
 - i. The Board discussed the current positions and decided to keep the positions the same.

d. PTO Presentations:

- i. Joel Deretchin Elementary School Representatives discussed the use of the funding from 2018 and students used the 3D printer purchased with last year's funding and won the science fair. The group of sixth graders designed a air pollution reduction device and they won the National Science Teacher Explora Vision competition. The students that won the competition are now in seventh grade and have returned to continue their science project. From the funds provided in 2019, the school purchased Oxobot Evo robots to begin teaching kids about coding. The 2020 funds will be utilized to purchase a set of Google Expeditions Virtual Reality Glasses. The Glasses are \$200/pair. The funds will be used to replace aging glasses. The school is sponsoring a 5k to give back to the community. This race for awareness is the 5th annual fundraising event and it will benefit The Woodlands Green Pollinator Conservation Program. Past recipients of this fundraiser have been the Families for Effective Autism Treatment, Love Fosters Hope supporting foster children, Periwinkle Community of Healing benefiting Arts in Medicine at the Texas Children's Hospital, and Inspiration Ranch a therapeutic horsemanship.
- ii. Coulson Tough Elementary School A representative for Coulson Tough was not in attendance.
- iii. Cedric Smith Elementary School This school is in Magnolia ISD but SRVA residents do attend the school. Past funding has assisted in purchasing a shade structure, SMART Boards, Chromebooks and Tech Tubs. Las year's funding was for musical playground equipment. Due to increasing the pre-k program, the funding will now be utilized to assist in purchasing playground equipment for younger children. The budget for the new playground equipment will be \$25,000 to \$30,000. They also fundraise through a school carnival and have about \$21,000 saved toward this playground equipment.
- e. President's Remarks and Presentations of checks and Congratulations. Eric Fishnaut thanked the school representatives for their presentations and informing the Board of the use of past funding. Patrick Graham made a motion to increase the donation to \$2,400 for Joel Deretchin Elementary for the glasses and \$2,500 for Cedric Smith Elementary to fund 10% of their fundraising effort toward the playground equipment. Joe Havrilla seconded the motion. The Motion passed.
