**STANDARD ITEMS**: This portion of the meeting, the community speaks to the SRVA to inform us of community information that is relevant to the SRVA purpose and mission.

- 1) Call to Order; Invocation / Pledge of Allegiance The meeting was called to order by Mr. Eric Fishhaut at 7:00PM CST.
- 2) Roll Call; must have a quorum of at least 5 Directors and at least 2 Officers present. *Mr. Fishhaut conducted roll call, attendance was captured for the meeting minutes.*
- Approval of the meeting agenda.
  Mr. Fishhaut made a motion to approve the regular agenda with the addition of speaking time for a MUD 46 board member. The motion was seconded by Mr. Wolff, the motion carried unanimously.

George Newman is a MUD 46 board member. Mr. Newman addressed the SRVA directors about a proposed reforestation project around the Spindle Tree jogging path area in the May Valley area of Sterling Ridge. The jogging path area has a drain basin for rainwater.

The proposed project is the result of citizen complaints regarding clear cutting of forested land for the Black Oak housing development. This land adjacent to the Spindle Tree jogging path.

The proposed project would include reforestation on the east and west sides of the drainage basin. With sufficient support, the MUD 46 board will present the project to the Woodlands Township. If approved this would be a cross functional project with support from the township, MUD 46, and HH Corporation. Additional research is required to make sure any reforestation not have a detrimental impact on the drain basin function or interfere with nearby overhead power lines.

*Mr.* Lederman made motion for the Sterling Ridge Village Association to support the proposed reforestation of the Spindle Tree jogging path area. Ms. Jackson seconded the motion. The motion carried unanimously.

4) Recognize public officials; The Woodlands Fire Department; Chief Palmer Buck Fire Chief Palmer Buck spoke to the board about the dry conditions caused by the ongoing drought. He noted several fires due to the dry conditions, the cause of the fires mentioned stemmed from transformer malfunctions and a BBQ on a wooden deck. Additionally, there have been brush fires throughout Montgomery *County. He urged caution to all residents and recommend removal of brush and pine needles from residents' homes especially on the roofs.*

- 6) MCSO Police Report; Specialist Eric Medina (936) 442-7797, Option 3 Sheriff Specialist Medina presented the police report for July 2022. At the conclusion of his report Specialist Medina informed the board he is leaving the Sheriffs office to pursue other career opportunities, and this would be his last meeting.
- 7) Township/Village Liaison Report(s); Amy Tidwell [See the attachments to this meeting package] Ms. Tidwell spoke about the National Night Out program and Adopt-a-Path Program. She informed us there are links and applications for both programs on the Woodlands Township Website.
